


My favorite game to play with Breezy was Chase.

## **Planning for our Pets**

Studies show that the majority of pet owners consider their pets to be members of their families, but how many have made decisions about what should happen to their pets in the event of the owners' death?

About one in five pet owners have made arrangements in writing, according to an NBC News report, for what happens, should their pets outlive them. The same report quotes the ASPCA estimate that "a half million owners die or become incapacitated each year without leaving instructions on how to care for their pets".

Many of these pets end up being surrendered to shelters and/or euthanized.

How can you make your wishes known about your own pets? An article on the Legal Language Services web site tells us:

The practice of including pets in wills isn't exactly standard yet. If you are drafting a will and want to include your pet, you may want to bring it up with your attorney, since your attorney won't likely be bringing it up first.

That being said, providing for pets in wills has become a lot more popular in the last decade, according to the Animal Legal Defense Fund. Pet owners are doing everything from specifying who should care for their pets to setting up pet trust funds to leaving entire estates to pets!

Another misconception is that remembering pets in wills is an American practice. The truth is that several countries, most notably England, have allowed provisions to benefit pets and other animals in wills for over a century!

The article goes on to say, "Leaving money or property to pets directly in wills is actually not legal since courts consider pets themselves to be property. However, setting up a trust for your pet is perfectly valid in over half of US states."

You may know of a couple who worked out a custody and/or visitation agreement after a breakup, or you may have read about celebrities like Katy Perry, who won custody of Krusty The Cat in her divorce settlement. Perry and then-husband Russell Brand each had a cat when entering into their marriage, and Krusty was adopted by both of them while they were married.

## Squirty's Words . . . From The Rainbow Bridge



In memory of Squirt, a longtime friend of Paws and Claws Society who passed away on Mother's Day 2011 at the age of 16½, Burlington Reports added a new section to remember pets who have passed. Ask Squirt a question, or share your pet memorial story on our web site (click on Burlington Reports). Let Squirt meet your pet(s) at the Rainbow Bridge and escort them to Pet Heaven.

**Question:** If I have a cold, can my cat or dog catch it from me? Can I catch a cold from my cat or dog?

**Answer:** A quick internet search on this question reveals that there are many differing opinions out there! To answer the question, we must first look at what we mean when we talk about a "cold". Many people confuse a cold with the flu. They can be very similar. In humans, a cold can be caused by any of thousands of viruses, while there are only three types of viruses that cause the flu, according to an article on the CBS News web site. The thing that seems to cause confusion about this question is that the *cause* of colds and flu in dogs and cats is different than in humans.

According to a post by an administrator on pets.ca, "In cats, the most common "cold" is viral (herpes/calici virus) and more recently it has been demonstrated they often get a bacterial "cold" from Bordetella bacteria. The most common "cold" that dogs get is a combination of Bordetella and Flu virus. In cats, they usually sneeze in rapid succession and dogs usually manifest as a cough". An article on pets.thenest.com tells us that humans cannot catch the feline type of herpesvirus or calcivirus. The Bordetella bacteria (Kennel Cough in dogs) "has been implicated as an infrequent cause of infection in humans, primarily in immunocompromised patients exposed to infected animals, although infections have also been reported in immunocompetent individuals as well," according to the Public Health Agency of Canada.

More than one commenter on forums and articles that turn up in a search of this question have said that their pets have, in fact, caught colds from them, although most medical professionals maintain that it isn't possible. What may have happened, however, is that the humans had the flu or another similar illness, which their pets caught, and in the pets it manifested as a cold.

The important thing is to always take precautions, just as you do to protect your own health. Keep your pets up-to-date with their vaccines, as many common pet illnesses can be prevented. Wash your hands often, keep surfaces in your home clean, and if your pet shows any signs of illness (cold symptoms or other symptoms), visit your veterinarian. Symptoms such as sneezing or watery eyes could indicate a cold, but also be sure to pay attention any time your pet is not acting like his or her usual self. Even changes in behavior such as going potty in inappropriate places can be in indicator of illness. An article on WebMD tells us that the six most common signs of illness (of all types) in our pets are:

- 1. Vomiting or Diarrhea
- 2. Lack of Appetite or Decreased Activity
- 3. Urinating More or Less Frequently
- 4. Coughing
- 5. Hair Loss or Itchy Skin
- 6. Stiffness, Lameness, or Difficulty With Rising





## **Registries For Animal Abusers**


While many legislators are working diligently in favor of a national registry for convicted animal abusers, similar to the national sex offender registry, there are groups, cities, and individuals who are also compiling records that can be very helpful in screening would-be adopters of pets for histories of abuse offenses.

Not only are animal abusers known for repeating their offenses, but links between animal abuse and violence toward humans are astounding. Rapists, spouse abusers, child abusers, and serial killers all have very high likelihood (up to 100%!) of a history of animal abuse.

A pdf on the Schenectady County SPCA web site lists national crime statistics showing that:

- 48% of convicted rapists abused animals in the past
- 70%-80% of spousal abuse victims situations have also included animals
- 88% of child abuse situations have reported cruelty to animals
- 100% of serial killers have abused animals
- 50% of all children and 66% of all male children are exposed to cruelty to animals

A registry of convicted animal abusers would not only alert animal shelters, veterinarians, and the public about potential



animal abusers in their communities, but would also provide an indicator of potential violence toward humans. If citizens and law enforcement can be aware of an animal abuser's presence before her or she abuses another animal, or hurts or kills a person, or commits the crime that lands him or her on the sex offender registry, perhaps many people and animals alike can be spared a lot of pain.
